

Plymouth City Council Meeting Proceedings
Thursday, March 7, 2024

The Plymouth Council met in regular session on Thursday March 7th, at 7:00pm.

Mayor Berding called the meeting to order with the following members present- Lissa Merfeld, Jay Stump, Neal Brennan, Wade Eastman & Allan Rye.

Others Present: Scott Ryg, Debbie Perry, Dianna Andersen, Craig Howard, Lori Meacham-Ginapp.

Motion to approve agenda by Merfeld, 2nd by Eastman. Motion carried.

Mayor Berding opened the public forum – Supervisor Ginapp spoke about June 4th election and absentee voting. Also updated council on Operation Green light for Veterans. Debbie Perry let the council know that if it is going to be as dry as it was last summer, she probably will not plant flowers this year, as carrying water is a lot of work. There were a couple of options discussed. Craig Howard asked about not getting mowing notices until after “No Mow May”.

Department Reports: Fire Department – Thanked Wade for getting an air compressor issue repaired and inquired about water ball fights at Applefest. Public Works –lagoon is ready for March 15th start date. Also let the council know he has an upcoming vacation and is working with Vermedal to cover in his absence. Clerk – Reminded everyone about City Wide clean-up May11th, with garage sales the Saturday prior. We received an Ins. check for the lift station failure, discussed Budget approval special meeting, Mayor Berding wanted to discuss delinquent utility bills which led to conversation about due dates which will be on the April agenda.

Old Business – golf cart type vehicle for street department – tabled to April.

New Business: Engel Agency gave update of Ins. renewal, discussion about traffic control options and Park signs. Motion by stump with 2nd by Brennan to purchase from the county three installed signs for \$375, motion carried. Motion by Eastman, 2nd by Merfeld to approve Resolution 2024-03 Disaster Mitigation motion carried. Employee reviews and wages were discussed with formal proceedings next month. Mayor Berding brought up Park clean up – motion by Brennan, 2nd by Eastman to contact the Central Springs Football team again to see if they are interested in helping for a donation. Motion carried. Asked Eastman about power washing some of the playground equipment. Motion by Eastman 2nd by Merfeld to pass Resolution 2024-02 to set Public Hearing on Code adoption. Motion carried.

Merfeld motioned to approve February minutes, 2nd by Stump, motion carried.

Motion by Rye to approve treasurer’s report 2nd by Eastman, motion carried.

Motion to approve February bills by Eastman 2nd by Merfeld, motion carried.

Comments from Mayor- stated CB would like to purchase vertical flags for Main St. need to contact Alliant about mounting on their poles. They have had two successful Bingo nights. Old siren tower could be used for weather cameras and sensors.

Comments from Council – Brennan will see if he gets the WCDA grant for ADA swings in park. Can collection has been slow. Stump inquired about delinquent Dog Licenses. Dunbar asked Eastman for a Work Comp update. Rye wants Dunbar paid for UB collection outside of regular office hours.

Motion to Adjourn by Merfeld 2nd by Rye, motion carried. The meeting was Adjourned at 9:08pm.
